Written Decision Documents for Contested Mount Union Claims

Chairperson Plautz pointed out that this is the first time we have done this at the recommendation of our Counsel, Emily Willits. Chairperson Plautz asked Emily Willits or Matt Rasmussen if they wanted to say anything before the Board acts on this matter.

Emily Willits replied that she wrote-up the draft Written Decision documents based on the minutes that Betty Hessing prepared. She thanked Betty Hessing for the detailed minutes, as those were very helpful. Given that these are contested matters with a possibility of an appeal, Ms. Willits thought it would be helpful to get the Board's approval on these Written Decision documents.

New Business

UA18-01 Ely Matt Rasmussen explained the City of Ely has presented paperwork for a 100% voluntary annexation of 100.44 acres, which includes 4.41 acres of road right-of-way. The current land use of this territory is agricultural and will continue to be used as agricultural after annexation. However, the current owners are working with the Ely Planning and Zoning Commission to change the zoning in the future to districts that will coincide with the Elv Comprehensive Plan. This will likely include highway commercial, single-family residential and multi-family residential properties. The Ely City Council has conducted an engineering study to run water and sewer services to this annexed area, along with other outlying potential developments. The territory is not subject to an existing moratorium agreement and the paperwork appears to be complete and properly filed.

Denise Hoy, City Administrator for Ely, was present via teleconference to explain further and answer questions from the Board.
