#### **New Business**

UA18-02 Storm Lake Matt Rasmussen stated this was a 100% voluntary annexation consisting of .861 acres, which does not include an adjacent road right-of-way. The requested annexation parcel is adjacent to the northeastern boundary of the City of Storm Lake and is located south of 600<sup>th</sup> Street and east of Redwood Drive, a private road. The parcel has received sanitary sewer service from the City of Storm Lake for several months, beginning in 2017, pursuant to a contract for such service between Ms. Hopper and the City. That agreement is why they are now requesting voluntary annexation into the City. Garbage hauling service is currently being provided. No use on the land received public water service from any source because the property has a well. Iowa Lakes Electric provides electric service to the property; they have a propane tank for gas. They do not have a telephone land line so they use a cell phone. They do not have internet service. They would receive public services such as police, fire and emergency upon annexation. There is no existing moratorium agreement between the City of Storm Lake and the City of Lakeside. The packet appears to be complete and properly filed.

SR25-0118 Dallas County -Waukee Matt Rasmussen explained that on February 13, 2018, the Board received a letter from Dallas County Board of Supervisors requesting the City Development Board annex in accordance with Iowa Code Section 368.7A, a section of County Road that has not been properly annexed into the City of Waukee. The legal description of the portion of 338th Court, along with maps depicting the secondary road which needs annexed to Waukee is in the Board packet. This is apparently a road that did not get annexed when Waukee did an annexation that was approved by the Board in October of 2017. Typically, as a normal course of business when we send out the final paperwork on an annexation, part of the legal description at the bottom, says that all secondary roads are annexed to the centerline, so it's just a matter of normalcy when there is an annexation that abuts up to a secondary road that it goes to the centerline. For some reason, this one did not get captured, so this is the

formality to get this portion of road annexed into the City

of Waukee. Barbara Brown

Matt Rasmussen explained this is a 100% voluntary annexation to the City of Orange City. The total area is 56.40 acres, with 12.70 acres being owned by the City of Orange City, an Iowa Municipal Corporation. The City of Orange City is presently looking into developing their entire 12.70 acres into low density residential housing for single family homes. Orange City Area Health System purchased 38.50 acres for future expansion of their assisted living units or development of senior housing units. Robert Wassenaar, Inc. at this time will continue to leave the remaining 2.60 acres as agricultural farmland. The City of Orange City does not at this time have any preliminary lot layouts for review, but has been in discussions with a private developer for the purchased area.

The City of Orange City requires the developer to install sanitary sewers, storm sewers and concrete streets with curb and gutter. The City will provide municipal natural gas, potable water, electricity, trash pick-up, police and fire protection. Telecommunications is provided to the area by Frontier, Premier and Long Lines communication centers. The City will also be installing adequately sized water mains to provide for fire hydrants. The area is not subject to an existing moratorium agreement and the packet appears to be complete and properly filed.

Kurt Frederes, Code Enforcement Officer for the City of Orange City, was present via teleconference to explain further and answer questions from the Board.

residential growth areas for the City of Norwalk and are contiguous to Norwalk's current city boundary.

The Lemar Koethe property currently has city sanitary sewer running through the middle of the property and is expected to develop in the near future. A pre-annexation agreement was entered into between the Bedwell's and the City. Services included in this agreement which the City is to provide include weekly residential solid waste and recycling pickup; weekly residential compost-it pickup; Norwalk City Police coverage; Norwalk City Fire & Rescue coverage; use of parks & recreation programs at city resident rates; City road maintenance; City snow removal from city roadways; City will work with adjacent owners during development to acquire easement for sanitary sewer tap; sanitary sewer tap fee shall be waived by the City (property owner is responsible for all installation costs); City will work to acquire water rights for the Bedwell propoerty; City will waive Water Tap Fee and any charges for water meters, which is a one-time waiver for initial installation of City meters.

The City of Norwalk has an annexation moratorium agreement with Des Moines and this annexation is consistent with that agreement. Mr. Rasmussen reported that this packet does appear to be complete and properly filed.
